
The turnout was great and everyone involved had a fantastic time.


During the month of October:



OCTOBER IN O.C. HISTORY



On October 15, 1903, the map for the Town of La Habra was filed with the County of Orange.

October 5, 1947

Beulah Overell and her fiancé George "Bud" Gollum were found not guilty of the murder of her parents. The elder Overell had been dynamited aboard their yacht in Newport Harbor. The trial, held at the Old Orange County Courthouse, was covered daily by the national press.

October 16, 1923

Walt Disney Company was founded. It would later play a major role in the Orange County's identity and economy.

October 20, 1938

The Trabuco Canyon Post Office was established.

October 24, 1917

A Liberty Bond rally was held in Birch Park in Santa Ana. This event featured patriotic speeches and music by the Santa Ana Band. The bonds helped finance the Allied cause during World War I.
