#### CLERK-RECORDER'S SANTA ANA LOCATION MOVING TO NEW COUNTY ADMINISTRATION SOUTH BUILDING

Clerk-Recorder Hugh Nguyen is proud to announce that the Clerk-Recorder Department will be serving the public at its new home inside the County Administration South building in Santa Ana, which is home to the County Service Center. The ribbon cutting and dedication for the County's much anticipated innovative building was held this past Wednesday by the Orange County Board of Supervisors. The new Clerk-Recorder Department location is located at 601 N. Ross Street, Santa Ana, CA 92701 and will open its doors from 8 a.m. to 4:30 p.m. on September 3, 2019 to serve the public.

The new office will offer customers the ability to obtain birth, death and marriage certificates, file a fictitious business name statements, record real property documents, notary registrations and much more. In addition, customers will also be able to obtain services from other agencies such as the County Treasurer-Tax Collector, the County Assessor, Health Care Agency- Environmental Health and OC Public Works.

"I am excited to move into the new County Administration South building," Orange County Clerk-Recorder Hugh Nguyen said. "It is a beautiful facility and the public will now be able to conveniently obtain a variety of services all at one location instead of having to visit several locations. The new building will be a great place for staff to work in with lots of natural light and visually pleasing."

The County Administration South Building is the first phase of a 20-year Civic Center master plan envisioned to improve the County's operational efficiency. The new building is a 250,000 square foot, 6-story office tower. It has two levels of underground parking and features a 7,200 square-foot conference center.

The Department is moving from the Hall of Records which was built in 1959. The building was originally named the Engineering and Finance Building. The Clerk-Recorder Department moved into the Hall of Records back in 1971. For 48 years, the office provided the public important services such as issuing birth, death and marriage certificates, document recording services, official records, and the filing of fictitious business name statements.

On August 21, 1906, Newport Beach votes to incorporate as a city. The measure to incorporate passed by a margin of 44 to 12.

- August 15, 1907 The Southern Pacific Railroad completes its "Orange County Loop Line," which includes stops in Newport Beach, Huntington Beach, Smeltzer (near Edinger Ave. and Gothard St.), Stanton, Santa Ana, and Anaheim.
- **August 30, 1946** The Coast Community College District is formed with the intent to acquire Santa Ana Army Air Base property for a junior college (Orange Coast College).
