The Santa Ana Preview is a group of individuals who organize meetings on a weekly basis for realtors, brokers, lenders and affiliates who come together to network and educate each other on their industry.

Hello, my name is Hugh Nguyen. I am honored to serve as your County Clerk-Recorder. As you may know, we offer many services that benefit Orange County residents and families at all four of our convenient locations, including: issuing birth, death and marriage certificates, passport services, registering notaries public and real property recordings.

We were the first county in the nation to record 7 million real property records electronically. We have been offering special Saturday hours for the almost four years, for which we received a 2014 Merit Award from the California Association of Counties as well as a 2015 Achievement Award from the National Association of Counties.

I attribute this success to my hard-working staff and I am proud to have the best county employees. I enjoy watching them provide great customer service. Every month I will be introducing some of my staff here and on our Facebook page, so that you may get to know my superstar employees. We are all here to serve you and we are proud to serve our County.

Today I would like to introduce you to Patrick. Patrick is our SECURE Project Manager and part of our Information Systems Unit. Patrick has worked for the County of Orange since 1998, when he was hired as a contract network engineer for the Health Care Agency (HCA). He stayed with HCA for two years, then was hired as network and desktop support at OC Waste and Recycling. In 2008, Patrick joined the Clerk-Recorder Department as our SECURE project manager. In addition to his duties in SECURE, in 2013, Patrick took on the responsibility of overseeing the electronic recording project for the Clerk-Recorder, which he still oversees today.

As part of his work with SECURE, Patrick is responsible for supporting 10 California counties and over 80 submitters to record their documents electronically. The Orange County Clerk Recorder was the first county in the nation to offer this service in 1997, and is currently the lead county for the state certified SECURE electronic recording delivery system.

Patrick is a dedicated employee. His years of diverse experience make him a wonderful asset to our team. He is always willing to learn new ways to improve our system, which helps our County remain a leader in electronic recording throughout the State of California and in the nation.

MARCH IN O.C. HISTORY



On March 8, 1952, the first El Toro Marines to return home from the Korean War arrived in Orange County

- March 2, 1857** Surveyor George Hansen was hired as superintendent by the Los Angeles Vineyard Society. He was given the job of locating and purchasing land for the new community which became Anaheim
- March 9, 1952** The Santa Ana Zoo was dedicated at Prentice Park.
- March 12, 1987** Orange County band **No Doubt** played their first gig at Fender's Ballroom in the City of Long Beach.
- March 21, 1929** Dana Point's Post Office was established.
