Public Notice

\$75 RECORDING FEE TO GO INTO EFFECT JANUARY 1, 2018

Pursuant to SB2 – The Affordable Housing and Jobs Act, the Orange County Clerk-Recorder is required to charge an additional \$75 per Title (up to a maximum of \$225) on certain real estate transactions effective January 1, 2018.

Per Government Code 27388.1 (a)(1) "A fee of \$75 dollars shall be paid at the time of recording of every real estate instrument, paper, or notice required or permitted by law to be recorded, except those expressly exempted from payment of recording fees, per each single transaction per parcel or real property. The fee shall not exceed two hundred twenty-five dollars (\$225)"

- **This new fee will be imposed on every qualifying transaction/document up to a maximum of \$225 not including recording fees.**

Per Government Code 27388.1 (a)(2) "The fee shall not be imposed on any real estate instrument, paper or notice recorded in connection with a transfer subject to the imposition of a documentary transfer tax as defined by Section 11911 of the Revenue and Taxation Code or on any instrument, paper, or notice recorded in connection with the transfer of a real property that is a residential dwelling to an owner-occupier."

- **To be exempt from this fee, a declaration of a valid exemption must be placed on the face of the document, or on a cover page, which will become part of the document prior to submission for recording. If no valid exemption is declared, the fee will be imposed.**

This fee is being charged in accordance with legislative amendment to Government Code 27388.1.





NOVEMBER IN O.C. HISTORY



On November 2, 1967, the City of Yorba Linda was incorporated with a population of about 11,433.

- November 06, 1905** The Pacific Electric Railway officially opened its line from Watts to Santa Ana. The first "red Car" in Santa Ana arrived a day earlier - a parlor car called Peregrino
- November 10, 1887** The tract map of the Town of Fairview, now part of Costa Mesa, was filed with the County of Los Angeles. (Orange County didn't exist until 1889)
- November 15, 1945** The Santa Ana Army Air Base closed. This WWII-era facility provided ground training for pilots and other crew. Today, the Orange County Fairgrounds, Orange Coast College and Vanguard University occupy some of the base's old footprint.
- November 22, 1901** Ten attorneys met in the newly completed Orange County Courthouse to found the Orange County Bar Association.
